1. Rejected previous MDTA Mobile classroom bids and authorized a new set of specifications for bid on portable classrooms.

2. Completed transaction for purchase of 48.81 acres bordering original 100 acre gift site on East 30th Street.

3. Agreed to plan a visitation of Southern California Junior College and Trade Schools January 11-15, 1965, for Board members, Staff members and Campus Planners.

4. Officially accepted the policy implications contained in the Staff Handbook.

Upon acceptance by the Student Council the Constitution will be voted on at a Student Body election. Larry Remington, Chairman of the Mascot and Nickname Committee, announced that final selections for the school nickname will be placed on the same ballot.

A Committee made up of Karen Moe, Chairman, Guy Hayes, Tom Speight, and Terri Knutson will investigate Student Dress Codes from other Community Colleges and prepare a proposed LCC Student Dress Code for presentation to the Student Council. The Traffic Committee--Jim Hurst and Brad Robinson, with Larry Remington as Chairman, has been authorized to work with adjacent property owners on the 1st and Monroe Street traffic problem, which has been aggravated by the increased traffic flow since the beginning of classes at LCC.

Policy from Student Handbook

Grading System

Grade definitions are as follows:

A. Indicates superior work, initiative and originality.

B. Indicates performance of assigned work in highly satisfactory manner.

C. Indicates adequate or average performance of assigned work.

D. Indicates barely passing work and that little or no initiative has been displayed.

E. Indicates "Incomplete." This indicates that for a justifiable, approved reason, (serious illness, etc.) a student failed to complete all requirements of the course. Such work must be made up during the succeeding quarter. Failure to make up incomplete work by the end of the succeeding quarter will result in the "E" being changed to an "F" on the permanent record. A student must petition before the end of a quarter for an "E" in each course in which an incomplete is sought.

F. Indicates failure, or failing to take a final.

F*. Indicates unauthorized withdrawal from a class or withdrawal after the fifth week with below "C" work in a course.

W. Indicates approved withdrawal from a course. A "W" indicates that the student withdrew from a course before the end of the fifth week or that he was earning a satisfactory ("C") grade if he withdrew after that time.

POLICY FROM STUDENT HANDBOOK Libray-Learning Resource Center

The LCC Library-Learning Resource Center provides a central grouping of conventional library materials and many other learning resources. The Center, in Room 66, Springfield Campus, will be open from 8:00 am to 9:00 pm Monday through Friday each week.

Students wishing to borrow books or use the Resource Center facilities must present a current student body card.

Fiction or non-fiction books that are not on reserve may be checked out for a twoweek period. Books may be renewed for two weeks providing a "hold" has not been placed on them.

The main card catalog is located at the LRC in Springfield. Books may be held for a student for one day if he calls the Center and leaves his name and the name and author of the book. Books may be returned to the LRC or to the bookstore on the Eugene Campus. Students should respect the rights of others by returning books on time.

POLICY FROM STUDENT HANDBOOK

Examination Schedule

Students are responsible for taking all assigned final examinations as they are listed in the final examination schedule. Faculty members will mention in each class the hour and day on which the . examination: for each class will be given. Final examinations will not be given in advance of scheduled time, except that students under extraordinary circumstances may petition the Academic Council in writing for special consideration. No instructor may give a final examination at any time except those listed in the final examination schedule unless it is approved in writing by the Assistant Dean of Instruction
