Standard & Poors, Bond Rating Service, announced today that LCC has received an AA rating for the pending bond sale.

It is highly unusual for a new community college to receive this high a rating, and it will reflect a sizable saving in interest over the life of the bonds.

#### WHERE ARE WE ON NEW CAMPUS Q. DEVELOPMENT?

- The Board, Staff, and Architects have been making steady progress in the development of the new campus on East 30th Avenue. Among significant major happenings are:
  - 1. Passage of a \$9.9 million bond issue September 20, 1966.
  - 2. The call for bids for the sale of the bonds has been set for December 7, 1966.
  - 3. Grading and site work are about 80% completed for the new campus.
  - 4. The Board of Education has approved final drawings for three mechanics buildings and two related structures. These buildings will be bid for construction January 4, 1967. Actual construction should begin about January 5 with completion of these structures within 1 year.
  - 5. East access road to the main campus will receive a base rock covering by mid-January, 1967.
  - 6. A total of 14 new buildings (first stage for 1400 day students) are planned for completion by fall of 1968. These will be bid periodically during the first half of the coming year.

WINTER TERM SCHEDULE AS USUAL

Upon the recommendation of Dean of Instruction William Hein and Dean of Students I. S. Hakanson, President Parnell is announcing today that the Winter Term schedule of classes will be planned on the basis of the present Fall Term pattern.

The proposed new 3M schedule has been discussed at length by faculty and students. As a result of these discussions it appears the new schedule would disrupt individual plans and work programs to the extent that re-study is in order. Therefore, students and faculty may count on the Winter Term schedule of classes in the traditional manner.

The common LCC problem, however, remains the same: how to accommodate more students in existing spaces. President Parnell has indicated plans for continuing study and discussion on this problem. The administration is committed to involving students and staff in the decision-making processes wherever possible.

It is currently planned that the Winter Term schedule of classes will be published in the December 8 issue of The Torch. Counselors should have rough draft copies of the Winter Term schedule around the 1st of December to allow for scheduling of students.

#### FROM THE PRESIDENT'S OFFICE

- Q. WHAT IS THE FINANCIAL PICTURE FOR LCC THROUGH JUNE, 1967?
- A. An unanticipated growth in community college enrollment throughout the State of Oregon has made State fund budget allotments insufficient to reimburse the community colleges fully for the 1966-67 fiscal year. A request to the State Emergency Board for additional funds has been taken under advisement and the State Board of Education has asked for a meeting with the Emergency Board in December. If funds are not obtained from this source a request will be made to the State Legislature for operating funds necessary to carry the community colleges through June, 1967.

Failure to receive money from either of these Boards could result in a curtailment of courses at LCC for Spring Term.

- Q. HOW CAN THE STAFF PARTICIPATE IN CAMPUS PLANNING?
- A. Staff members at LCC last year were involved during the initial campus planning. Present involvement is being carried out through the Division Chairmen, Advisory Committees, etc. Also, the Inservice December 19-21 will be devoted almost entirely to developing room specifications for the new campus.

Instructors having suggestions or comments—should take them to their Division Chairmen for consideration.

#### FROM THE PRESIDENT'S OFFICE

- Q. WHAT IS THE FINANCIAL PICTURE FOR LCC THROUGH JUNE, 1967?
- A. An unanticipated growth in community college enrollment throughout the State of Oregon has made State fund budget allotments insufficient to reimburse the community colleges fully for the 1966-67 fiscal year. A request to the State Emergency Board for additional funds has been taken under advisement and the State Board of Education has asked for a meeting with the Emergency Board in December. If funds are not obtained from this source a request will be made to the State Legislature for operating funds necessary to carry the community colleges through June, 1967.

Failure to receive money from either of these Boards could result in a curtailment of courses at LCC for Spring Term.

- Q. HOW CAN THE STAFF PARTICIPATE IN CAMPUS PLANNING?
- A. Staff members at LCC last year were involved during the initial campus planning. Present involvement is being carried out through the Division Chairmen, Advisory Committees, etc. Also, the In-Service December 19-21 will be devoted almost entirely to developing room specifications for the new campus.

Instructors having suggestions or comments should take them to their Division Chairmen for consideration.
