The event will take place at 8 p.m. in the cafeteria area of the Center. LCC counselor Steve Hanamura will give the invocation. Others participating in the program will be George Lauris, Performing Arts instructor; Mrs. Anita Robinson, class president; Evelyn Alford, Nursing instructor; and Nursing Chairman Mary Fiorentino.

Members of the Eugene Licensed Practical Nurses Association will serve at a reception following the ceremony.

Friday morning, Nursing instructors will hostess a coffee hour and buffet-brunch in honor of the graduates at the Inn of Eugene from 9-11 a.m.

Tonight's pinning ceremony signifies the students' successful completion of the four-quarter training program. They still must pass the State Board of Nursing Examination in September to qualify as licensed practical nurses.

REVISED "1990 Plan" OPPOSES DEVELOPMENT AROUND LCC

Among the changes in the revised Eugene-Springfield Metropolitan Area 1990 Plan is one concerning land use around LCC.

Two years ago when the preliminary 1990 Plan was drafted, it suggested residential development around the college. However, the revised 1990 Plan, does not recommend any development in the immediate future—mainly because of the lack of sewer facilities.

"At the present time, the plan says, "any development around Lane Community College would demand a disproportionate share of public investments and would direct development and public monies away from areas of higher priority."

The 1990 Plan was drafted by county planners and is intended to establish guidelines for the orderly future development of Central Lane County. Public hearings on the revised document will be held during the next two months, after which the 1990 Plan is expected to be formally adopted by the elected officials of Eugene, Springfield and Lane County.

LANE COMMUNITY COLLEGE

INSTITUTIONAL BILL OF RIGHTS, RESPONSIBILITIES, AND CONDUCT

Preamble

Lane Community College serves society by providing programs of learning which enable students to pursue and achieve their educational and vocational goals. Free inquiry and free expression are indispensable to the pursuit of these objectives. The transmission of knowledge, the search for truth and the development of the student depends upon appropriate opportunities and conditions in the classroom, on the campus, and in the community. In order that the College can provide conditions which are conducive to the effective performance of its purposes, each member of the college community, administrators, faculty, students, and others acknowledges a commitment to those purposes and to the principles of democratic freedom for himself and others.

Short Title

Section 1: This document shall be known as the Institutional Bill of Rights for Lane Community College.

Terms

- Section 2: When used in this document --
 - A. The term "college" means Lane Community College.
 - B. The term "administrator" means those responsible for the operation of the College.
 - C. The term "student" includes all persons taking courses at the College both full-time and part-time, pursuing high school completion, technical-vocational, lower division collegiate, adult education, or extension studies.
 - D. The term "instructor" means any person hired by the College to conduct classroom or counseling activities.
 - E. The term "classified" encompasses all those employed by the College to conduct functions other than the above.
 - F. The term "shall" is used in the mandatory sense.
 - G. The term "may" is used in the permissive sense.
 - H. All other terms have their natural meaning unless the context dictates otherwise.

Access to Higher Education

- Section 3: The College shall be open to all applicants who are qualified according to its admission requirements. Under no circumstances shall an applicant be denied admission to this college because of race, religion, sex, national origin, political belief, age, or previous criminal record.
 - A. Previous academic status at other institutions shall not constitute criteria for denial of admission to this college.
 - B. Preference for admission shall not be based on economic status.

Classroom Expression

- Section 4: Freedom of discussion must be protected and expression of views must not be inhibited. The instructor has the responsibility of maintaining a classroom environment conducive to the learning of the subject, but his authority must not be used solely to suppress the expression of views contrary to his own. It is the responsibility of the student to support the instructor's efforts to assure freedom of expression and to maintain order.
 - A. Students are responsible for learning the content of any course for which they are enrolled. Instructors shall provide for the student every available opportunity for the accomplishment of this goal.
 - B. Requirements of participation in classroom discussion and submission of written exercises are not inconsistent with this Section.
- Section 5: Academic evaluation of student performance by instructors shall be based upon academic achievement. Academic evaluation shall under no circumstances be prejudicial or capricious. Instructors will be expected to state course content and objectives at the beginning of each term and throughout the term as the need arises.
 - Section 6: Information about a student's views, beliefs, and political associations acquired by LCC employees is confidential and is not to be disclosed unless required by state or federal law.

Campus Expression

- Section 7: Discussion and expression of all views within the College shall be limited only by civil and criminal law.
- Section 8: Members of the campus community shall have the right to freely and peaceably assemble and demonstrate in accordance with the exercise of constitutional rights so long as such activity does not impede the rights and freedom of others.

- Section 9: Lane Community College employees and students shall have the right to be interviewed on campus by any lawful organization desiring to recruit at the College. Lane Community College employees and students may protest against any such organization provided that protest does not interfere with any other individuals's right to have such an interview, or does not interfere with the privilege of the recruiting personnel to hold said interview.
- Section 10: Lane Community College employees and students can invite to the campus and hear any person(s) of their choosing.

Campus Organization

- Section 11: Organizations can be established by Lane Community College employees and students, within the College, for any lawful purpose.
- Section 12: Membership in any campus organization, including those affiliated with an extramural organization, shall not be denied because of his race, creed, sex, economic status, or national origin, except that religious qualifications may be required by organizations whose aims are primarily sectarian.
- Section 13: The College shall make available the use of its facilities by members of the college community. College facilities may be assigned to Lane Community College employees and students for meetings, for social programs, and for programs open to the public.
 - A. Conditions may be imposed to regulate the possibility of requests, to determine the appropriations of the space assigned, and to ensure proper maintenance. Allocation of space shall be made based on chronological priority of requests and the needs of the organization, individual, or group.
 - B. Preference in assignments shall be given to programs instituted by Lane Community College employees and students.
 - C. The College shall delegate the authority of the assignment of facilities.
 - D. Physical abuse of assigned facilities shall result in demands for restitution for damages from the sponsoring party or parties.
 - Section 14: No Lane Community College employee, student, or group may use the college name in purporting to be representative of the

Student Records

- Section 22: The privacy and confidentiality of all student records and copies of same shall be preserved. Student academic records, supporting documents, and other student files shall be maintained only by regularly employed members of the college staff employed for that purpose. Separate files of the following may be maintained by the proper college officials: (1) official academic records, supporting documents, and general educational records; (2) primary and secondary records of discipline proceedings; (3) medical and psychiatric records; (4) financial aid records; and (5) college security records.
- Section 23: No entry shall be made on a student's academic record, and no disciplinary or evaluative document or commentary may be placed in his file(s) without prior written notice to the student.
 - A. Any student challenging the accuracy of any entry or the presence of any item has the right to appeal through standard grievance procedures.
- Section 24: Access to his records and les is guaranteed every student subject only to reasonable regulation as to time, place and supervision.
 - A. A copy of any and all of his records and files shall be made available to the student upon request, subject to a reasonable charge.
- Section 25: Except as required by state and federal regulations, no record may be kept in relation to any of the following matters except upon the express written consent of the student:
 - A. Race;
 - B. Religion;
 - C. Political and social views;
 - D. Sex; and
 - E. Membership in any organization other than honorary and professional organizations directly related to the educational process.
- Section 26: No information in any student file may be released to anyone, except with the prior written consent of the student concerned or as stated below:
 - A. Members of the faculty, with specifically stated administrative, counseling or teaching assignments, may have access for internal educational purposes as well as necessary administrative and statistical purposes.

College or any of its various organizations or sections without the express permission of those he wishes to represent.

Campus Media

- Section 15: Anyone may distribute extra-curricular leaflets, posters, and pamphlets on campus with prior authorization of the Student Director of Publicity. Authorization for distribution of material shall be based solely on existing publicity guidelines and shall be neither prejudicial nor capricious.
 - Section 16: The student press is to be free of censorship and advanced approval of copy. The editors and managers shall not be arbitrarily suspended, suppressed or intimidated because of student, student government, employee, alumni, or community disapproval of editorial policy or content. Similar freedom is assured oral statements of views on college-controlled and student-operated radio or television stations. This editorial freedom entails a corollary obligation under the canons of responsible journalism and applicable regulations of the Federal Communications Commission.
 - Section 17: All College published and financed communications in which editorial comment is included shall explicitly state on the editorial page or in broadcast that the opinions expressed are not necessarily those of the college, employees, the student government, or the student body.

College Student Government

Section 18: The student government (ASLCC) shall be considered as the embodiment of student representation separate from the college administration and not a department of the Board of Education of Lane Community College or any of its legal representatives.

Employee and Student Participation

- Section 19: On questions of college policy, the Board and its representatives shall utilize the advice and assistance of employees and students. The Board alone, however, will serve as the final policy-making body.
- Section 20: On questions of college administrative regulations, the President and his representatives shall utilize the advice and assistance of employees and students. The President alone, however, will serve as the final decision-maker.

Privacy

Section 21: Lane Community College employees and students shall have the same rights of privacy as any other citizen and none of these rights by becoming members of the academic community. No inquiry shall be made into the private activities of Lane Community College employees and students away from the campus, where their behavior is subject to regulation and control by public authorities.

- B. Information as to whether or not a student is currently enrolled as a student of Lane Community College may be made available upon verbal or written request.
- C. The following data may be given any inquirer upon written request: school or division of enrollment, period of enrollment, degrees awarded, honors, major field, and date of graduation.
- D. Properly identified officials from federal, state, and local government agencies may be given the following information upon express request in addition to that in Section 28-C: name and address of parents or guardian if student is a monor, and any information required under legal compulsion.
- E. Except as herein stated, access to a student's file shall be denied to any person other than the student.
- Section 27: Except as required by law, no record may be preserved beyond graduation for more than one calendar year except:
 - A. Academic records subject to the limitations of non-disclosure;
 - B. Financial records of continuing obligations;
 - C. Medical and psychiatric records subject to complete nondisclosure; and,
 - D. Disciplinary records restricted to: (1) nature of offence; and (2) action taken.

Employee Records

- Section 28: Records shall be established in order to determine and evaluate the qualifications of prospective employees in accordance with Oregon Board of Education regulations.
- Section 29: Records may contain a completed application, records of interviews, a signed contract where applicable, and payroll information. All additional materials shall be placed in these records only with prior written notification to the employee. The employee shall have the right of appeal to have any such material deleted.
- Section 30: Except as required by state and federal regulations, no record may be kept in relation to any of the following matters except upon the express written consent of the employee:
 - A. Race;
 - B. Religion;

- C. Political and social views;
- D. Sex; and
- E. Membership in any organization other than honorary and professional organizations directly related to the educational process.
- Section 31: All records, with the exception of references from placement services labeled confidential, shall be available to
 the employee, subject to a reasonable charge. Employee
 records shall not be released without the employee's consent except as
 subject to subpoena or as necessary for administratively approved
 employment procedures.
- Section 32: All portions of an employee's record that make reference to employment other than with Lane Community College shall be destroyed upon termination of employment with the college.

<u>Violation of the Law and College Discipline</u>

- Section 33: The college may institute its own proceedings against a student who violates a criminal law on campus which is also a violation of a published college regulation.
- Section 34: If a student is arrested, indicted for, or convicted of an offcampus violation of law, the matter shall be of no disciplinary concern to the College unless the student is incarcerated and unable to comply with academic requirements.

Student Sanctions

- Section 35: The following sanctions may be imposed upon students and shall, ordinarily, be administered in sequence.
 - A. Admonition: an oral statement to a student that he is violating or has violated college rules.
 - B. Warning: notice, orally or in writing, that continuation or repetition of conduct found wrongful, within a specific period of time stated in the warning, may be cause for more severe disciplinary action.
 - C. Censure: a written reprimand for violation with or without stipulation regarding forfeiture of privileges, including the possibility of more severe disciplinary sanctions in the event of a violation of any college regulation. This censure may be imposed by the Dean of Students or a student judicial body subject to an appellate hearing in accordance with standard grievance procedures.

D. Restitution: reimbursement for damage to, or misappropriation of, property with written student agreement of the terms. This may take the form of appropriate service or other compensation. E. Suspension: dismissal from the college as set forth to the student by written notice for a definite period of time, not longer than one academic term. F. Indefinite Suspension: dismissal from the college as set forth to the student, by written notice, without a date established for the privilege of applying for re-admission. Such application is to be reviewed and acted upon by the Dean of Students and/or the appropriate judiciary body. G. Expulsion: permanent or conditional separation from the college. The conditions of re-admission, if any, shall be

stated in the order of expulsion.

- H. All of the above sanctions are subject to standard grievance procedures as outlined in the By-laws of the Associated Students' Constitution (ASLCC).
- If the Dean of Students and/or other designated body decides that Section 36: the student(s) should be separated from the college as defined in Sections 35-F or 35-G, it recommends such action through the Dean of Students and the President and the college Board. Approval of the Board is required for all such actions of separation.
- Section 37: Any disciplinary action may be recorded separately in the student's file in the office of the Registrar.
 - The Dean of Students and/or other designated body shall have the power to delete from the student's file any or all disciplinary records.
 - B. All students shall have the right to show cause before the Dean of Students and/or other designated body as to reasons for the deletion from his files any or all disciplinary records.
 - C. Appeals for the deletion of disciplinary records are subject to the standard grievance procedure.
- No sanction may be imposed for a violation of any College rule or Section 38: regulation that has not been published and been made freely available to all students.

Standards for Disciplinary, Appeal, and Grievance Proceedings

- Section 39: Lane Community College employees or students, engaged in disciplinary, grievance, or appeals procedures shall have the right:
 - To have a hearing before the procedurally appropriate person or body,
 - B. To appeal any decision made through appropriate steps to the college Board of Education,

- C. To be given notice in writing of the specific charge against him,
- D. To be given adequate time in which to answer or to prepare a defense to such charge,
- E. To appear alone or with any other person of his choice to advise or assist him,
- F. To refuse to testify or to answer any questions if such testimony or answers would tend to incriminate him,
- G. To be confronted with the evidence against him,
- H. To present evidence in his own behalf,
- I. To be confronted by his accuser(s),
- J. To cross examine his accuser(s) and witnesses appearing against him,
- K. To have a copy of the proceedings provided at the college's expense,
- L. To have an open hearing of his case if he so desires,
- M. To require proof beyond a reasonable doubt be submitted by his accuser(s), and
- N. To have penalties imposed that are commensurate with the violation charged.

Unenumerated Rights

Section 40: The preceding enumeration of rights shall not be construed to deny or disparage others retained by employees and students in their capacity as members of the campus community or as citizens of the community-at-large.

Ratification

Section 41: This Bill of Rights, Responsibilities, and Conduct when ratified by the Board of Education of Lane Community College, shall be utilized as the guiding Board policy institutional rights document. All amendments to, additions to, or deletions from this document shall be submitted for consideration to the Lane Community College Institutional Rights Review Board. This board shall consist of one administrator, one faculty employee, one classified employee and three students appointed by their various sections and confirmed by the College Board.

APPEALS REVISIONS APPROVED:

Changes in the college appeals system proposed by the SPPC were approved by the Board last night, with the exception of a section guaranteeing classified as well as contracted staff pay during the appeals period.

The revised appeals policy combines two former Board policies into one which both establishes the right to appeal and outlines the grievance procedure. The new policy also stipulates that at each step in the appeals process, the administration is required to provide the appellant an answer to his appeal within six calendar days.

In defending the SPPC proposal to grant classified employees pay while processing an appeal, SPPC Chairman Jim Snow said his committee feels classified staff should be treated the same as contracted under the appeals policy. This means the employee would continue to receive pay for a maximum of 30 days required for the entire appeals procedure.

The administration, however, supported college attorney Edward Harms' opinion that "staff members not under contract may be suspended without pay or discharged pending any appeal," with the provision that back pay may be given if the suspension or discharge is found to be without just cause. In his written opinion to the Board, Harms said he knows of no personnel system, including civil service, which grants classified personnel suspension with pay.

Board Chairman Catherine Lauris and Vice-Chairman Robert Mention supported the SPPC position. Board member Robert Ackerman said he feels the concerns of classified staff "have merit" but that the provisions for granting pay during the appeals period should be considered and negotiated as part of the terms and conditions of employment of classified staff. These terms are to be reviewed by the Board at a future meeting, he said.

The Board adopted the appeals policy revisions, incorporating Harms' opinion. Mention cast the only dissenting vote.

IN OTHER MATTERS, the Board:

- ** Completed its review of the 41-section Insitutional Bill of Rights and referred it for final action at the Sept. 8 meeting.
- ** deferred action on proposed changes in the Board policy on Copyrights/Patents, asking for a clarification of the process the college or an individual staff member would follow in copyrighting materials. The matter has been considered by various staff committees and on and off the Board agenda for the past five months.
- ** Revised Board policy 511.1 to state that preference in admission to college programs will be given to in-district applicants until a date established by the administration for each college year rather than the July 1 deadline set in the former policy.

BOARD MEETING cont.

- ** Approved changes in current Associate of Arts degree requirement which make them more in line with transfer requirements of four-year colleges.
- ** Approved an addition to current Associate of Science Degree requirements, granting that "A maximum of 48 hours may be gained through relative educational and/or work experience." In his memo to the Board, Dean Carter explained that this provision permits a student to be placed at his level of competency and progress from there without having to buy the credits. "The existing policy on degree requirements allowed students to receive credit for previous experience on the basis of an examination costing them \$4 per credit hour.
- ** Approved the addition of an Associate of General Studies Degree, allowing students to earn an associate degree without having to complete a specific occupational or transfer program. To qualify, a student must complete a minimum 93 term hours of vocational or college transfer courses with a cumulative grade point average of not less than 2.00. Specific subject area requirements are included, however.
- ** Heard Dr. Schafer report that the administration is currently reviewing recommendations in the recently completed Classified positions study. The Board deferred until its next meeting discussion of the study to allow Board members to read the study carefully. The Board also deferred discussion of responses to staff concerns expressed during the Board-section meetings last spring.
- ** Gave final approval to a \$58,400,000 student body budget for 1971-72. The budget had been amended as a result of Board action increasing student fees for part-time students. The additional \$4,000 revenue expected has been allocated to the athletics program, raising student body support from \$13,600 to \$17,600. The final appropriation is still \$9,000 short of the amount sought by the Athletics Dept.

LABOR ENDORSES BUDGET: The Lane County Labor Council has unanimously voted to support passage of the LCC budget levy. The announcement was made by Irvin Fletcher, secretary-treasurer of the Council which is composed of 880 delegates from 39 Lane County AFL-CIO affiliates, representing more than 5,000 union members.

A LOOK AT this past year's enrollment figures reveals there's a lot of LANE in Lane Community College.

Over 90% of the student body this year came from the college district, and 98% were Oregonians. In-state but out-of-district students contributed 7.23%, those from other states, 1.75%, and foreign students, .71%.

The total headcount for 1970-71 was 17,748. This includes both full-time and part-time students in credit classes and those taking non-credit adult education courses. Part-time students accounted for two-thirds of the headcount, with the FTE totaling 5,577.

AN INTERESTING SIDELIGHT to the enrollment count is the fact that over half of the students taking credit classes last year were age 21 or above. The breakdown was:

Age 21-29 37.6% 30 and over 14.7% 20 and under 46.7% unknown 1.0%

THESE FIGURES show LCC caters to both the young and the young in spirit, while providing educational opportunities first and foremost to Lane County residents.

MORE STATISTICS: Institutional Research's final compilation for the past school year show these breakdowns for the percentages of LCC's total FTE hours taught by each department:

14% -- Social Science; 11% each -- Adult Education and Language Arts; 10% -- Business; 8% -- Science; 7% each -- Math and Mechanics; 5% each -- Industrial Technology and Health and Physical Education; 3% each -- Special Training Programs, Art and Applied Design, Electronics; 2% each -- Mass Communications, Nursing, Home Economics; 1% or less -- Data Processing, Paradental/Paramedical, Performing Arts, Study Skills Center, Food Technology, Flight Technology.

 - ** Staff members, and particularly the president, have been talking to various local groups--from the Demo Forum to the Used Car Dealers' Association--to stress the importance of a "yes" vote on Thursday.

A NOTE FROM THE PRESIDENT ON STAFF SALARIES:

In my memo to the staff on Aug. 12, I stated that upon passage of the budget by the voters on Aug. 26, all employees' salaries would be recomputed at the 1971-72 level and be retroactive to July 1.

With the wage and price freeze inaugurated by President Nixon, that promise must now be held in abeyance. We cannot legally change any salary to a level higher than that experienced in the period july 14 to Aug. 14. This means, then, that the 5 percent grant on last year's salary schedule remains in effect since it occurred during the specified dates, but that any further change cannot be made until the freeze is lifted or clarified.

It is my opinion that contracts signed in good faith should be honored, but until higher authorities have interpreted President Nixon's freeze order, we can only speculate.

THE COLLEGE CABINET will meet at a new time - 3 p.m. - starting tomorrow. Agenda items include discussion of records keeping, emergency public employment grants, and the administrative retreat, and reports on budget election activities and the staff in-service week planned for Sept. 13-24.

Two elections of countywide importance


Lane's county government and Lane Community College District both are still short on authorizations for tax support of 1971-72 operating budgets.

Both have tried twice before to gain voter approval of tax levies "outside the 6 per cent limitation" to help fund budgets for the fiscal year that actually began July 1. Both have twice failed to gain that approval.

So Lane County and LCC will hold "cut-rate" elections concurrently this Thursday. That is, they will hold simultaneous elections in which they will be asking what their elected policy makers and citizen budget committee members believe to be bedrock tax levies necessary to keep county government and the community college from being forced to make drastic cuts in their 1971-72 operations...

At stake for LCC Thursday will be \$977.223 — a bit more than one-quarter of all property tax support the community college needs to finance an already twice-trimmed 1971-72 budget. However, if this is approved, the resulting 1971-72 total levy upon a \$20,000 property to operate job-training and academic instruction programs for some 6,000 "full-time equivalent students" (about 18,000 individuals) will still be no higher than \$35.60.

The Register-Guard recommends passage of both the Lane County and LCC tax proposals on Thursday. Defeat of either or both would be quite costly in terms of vital public services but wou'd cause barely noticeable reduction in the overall tax bills paid by residents of this county and the community college district. Taken together, the county government and LCC special tax-requests amount to less than the costs of building one mile of superhighway.



VOTE EARLY: It's OK if you're late for work tomorrow--provided your excuse is a stop at your polling place.

DR. SCHAFER suggests that all staff members vote BEFORE coming to work tomorrow.

Polls open at 8 a.m. Check Tuesday's Register Guard or the second floor, administration bulletin board for a listing of polling places.

ADDITIONAL VOLUNTEERS are needed to call voters on election day and remind them to go to the polls.

STAFF CONTRIBUTIONS to the Open Door Committee now total \$977.75, just short of the \$1,000 goal. The money has been used for radio spots, mailings to alumni and School District 4J employees, and other campaign activities.

A CROUP OF LCC STUDENTS has been calling the newly-registered 18-21 year-old voters to remind them of Thursday's election.

REGISTRAR BOB MARSHALL REPORTS the Medical Office Assistant and the Forestry programs are completely full for Fall Term and both have long waiting lists.

The medical and dental programs, which enroll students through a special selection process, have been full for some time.

COUNCIL PROPOSES REFUND POLICY: The Instructional Council has endorsed a counterproposal to the new guidelines for refunding tuition and fees set for Fall Term.

In the past, students withdrawing from the college before the sixth week of a term have received a full refund, less the \$10 pre-registration fee.

However, under the new guidelines approved by the president, refunds for students withdrawing from school or dropping from full-time to part-time status will be granted on a prorated scale, allowing a full refund (minus the \$10 pre-registration fee) during the first week of classes and 20 percent less for each succeeding week up to the end of the fifth week of a term.

The Council's recommendation is to limit the refund period to the first two weeks of a term and to give a full refund the first week and 75 percent of that amount the second week. No refunds would be made to those withdrawing after the second week.

The Instructional Council adopted this proposal at its Aug. 19 meeting. It will be forwarded to the president with the recommendation that the changes be implemented Winter Term. Originally, the refund proposal before the Council advocated giving refunds only during the first week of a term. However, this was amended to extend the proposed refund period to two weeks.

BUDGET DEFEATED BY WIDER MARGIN: The wage-price freeze, the county budget, and the Saturday Market were all cited as possible reasons for the defeat of LCC's budget for the third time yesterday.

In a confusing about-face, LCC district voters turned down the measure by a 12,321-7,727 margin, defeating it by a greater percentage than in the June 29 election.

No one had any concrete explanation as to why the budget, which was cut by \$117,651 since the last election, fared poorer than the June measure. Voters rejected the June 29 request 10,488-8,295.

Speculation on the disappointing results ranged from national to local reasons. Some persons present at the vote tabulation center in the courthouse basement last night predicted that if the budget had been run two weeks ago--before the wage-price freeze--it would have done considerably better. Others theorized that running the LCC measure with the county budget was a "kiss of death." They contended the widespread opposition to the county request brought out the negative voter who cast a "no" ballot on everything.

The budget did not pick up its usual heavy support in Eugene. The opinion was expressed last night that this again may have been due to the county budget measure which possibly lost support in Eugene because of the Saturday market controversy.

VOTER TURNOUT UP SLIGHTLY

More voters turned out for yesterday's election than did in the two previous attempts. However, of the 20,278 who voted, 61% cast "no" votes as against 38% "yes". The June 29 levy lost by a 53-47% difference, with a total vote of 18,783. On April 13, the total vote was 17,505, and the budget was defeated 11,592-5,913.

Returns came in very slowly, with the computer giving the final printout totals at 11:50 p.m. The election was the first in which LCC used the votomatic computerized balloting supervised by the county. Because of the computerization, the traditional precinct totals were not available last night. The precincts were grouped into voting blocks for easier counting.

CITY OF COTTAGE GROVE ONLY VICTOR

It was apparent that misery loved company yesterday as all but one of the five tax levies were defeated.

The Cottage Grove city budget was approved 532-475. The county budget took the biggest licking, losing 14,108-5,982 (70% no vote). Other defeats:
