WHY YOU CAN BE PROUD OF CWE

LCC's Cooperative Work Experience program is the nation's largest among community colleges. It enrolls 2,300 students, a fourth more than anyplace else. There are 750 employers, or field faculty, including 100 out of district in 17 foreign countries and 12 other states. They pay students \$4 million a year in wages. The national average for employer longevity is about three years. LCC has 100 who have been in the program 10 or more years. CWE, through Director Bob Way, has won a half million dollars in grants; thus the College has never had to spend capital outlay money for the program. Last summer, delegations from colleges in five states, the farthest from New York, came to LCC to talk to the director, 34 instructor-coordinators, and support staff.

ENROLLMENT NEWS

Fourth week fall enrollment projections indicate that LCC is showing an increase in FTE. The graph depicts fall enrollment trends since 1980. Fourth week projections have typically been very accurate, so we expect the final FTE for the term to be very close to our projection of 2,324, an increase of approximately 200 over fall 1987. Almost every program area is up, with the largest increase showing in lower division credit (transfer) area. A+ for Cushy Shoes

L ighter doesn't always mean better, at least when it comes to running shoes. As reported by HEALTH Magazine, researchers at the University of Tennessee at Knoxville tested two different types of running shoes. They found that runners wearing heavier, well-cushioned shoes used about 2.4 percent less oxygen than those in lighter, non-cushioned ones. They attributed this lower demand for oxygen and energy to air cushions, which helped the runners' feet to rebound faster.

Researchers also applauded the heavier shoes for providing added protection from injury by reducing the force of impact.

You've devoured your Thanksgiving Day feast. And if you heeded the advice of experts, you bought the biggest bird you could find. Not all of it was eaten. Now, you're wondering, "Besides those great turkey sandwiches, how else can I use this delicious turkey?"

Turkey is so versatile, you don't have to go cold turkey with leftovers; instead, make appetizing "planned-overs." As you snap on the last storage container lid, think of turkey, stuffing, cranberry sauce, and holiday fruits as buried treasure waiting to be rediscovered in exciting new recipes.

But first, follow these basics immediately after the big feast: • Carve meat from turkey bones.

- Place meat in covered containers and store in coldest part of refrigerator. Allow space around food for adequate air circulation. Cooked turkey may be stored in the refrigerator 2 days (longer if mixed with other foods).
- Make a rich broth from turkey carcass. Broth may be frozen if not used within 3 days.
 For make-ahead convenience, prepare recipes, divide into serving sizes for your family, cover, and freeze.

Cooked turkey may be frozen for aslong as 4 months. For eight exciting new recipes that use your leftover turkey, write to the National Turkey Federation, 11319 Sunset Hills Road, Reston, VA 22090. Ask for their "Turkey Planned Overs" brochure. Include a legal-size, self-addressed, stamped, return envelope.

WHAT TO DO WITH A TOOTH THAT IS K.O.'d. Don't despair if you or your child knocks out a permanent tooth. Act quickly and you can often help save it. Here's what to do.

1. Find the tooth. If it fell out of the mouth, rinse it gently under running water. Do not touch its root.

2. Keep it moist. Put the tooth back into the hole it came from; between your cheek and gum (or your child's cheek and gum, if you're sure the child won't swallow it in the excitement); or in a container of milk.

3. Call your dentist immediately. You only have about 30 minutes to replant the tooth.
