## OD plan to be developed

A broad-based participative group to develop an organizational development (OD) plan for Lane will be formed soon, Executive Dean Larry Warford told College Council members last Tuesday. The group will look at OD plans from other community colleges and discuss a timeline for developing a plan for Lane.

In other business, the Council decided to re-write a statement on shared decision-making to make it into possible Board policy, discussed the possibility of a tuition hike for 1990-91, and considered recommending to the Board that it ask voters to approve a three-year serial levy of about \$750,000 a year to continue funding for equipment and maintenance.

The main item for tomorrow's College Council meeting is 1990-91 tuition. Other topics include Ed-Net, Child Care Task Force, and a possible Board policy on shared decision-making. The Council meets from 2 to 5 p.m. in the board room. All meetings are open to staff.

## Role clarified

The assignment for a Child Care Task Force to be organized soon is to look at needs, not to evaluate existing child care programs. Interim President Jack Carter announced the distinction to clear up confusion over the role of the group. Vice President Jacquee Belcher is organizing the effort.

## More holiday tips

\* Try to identify which traditions have meaning and which just clutter up the holiday.

\* Take a look at your holiday spending patterns and try to identify areas of change. You could, for example, give a coupon book to child. Each coupon would read: "This coupon entitles you to..." A coupon could be good for a trip to the park or museum, a friend over for the weekend, a movie rental, a day off from chores, breakfast in bed, or the child's choice of a dinner menu.

Be sure you can deliver on coupons, and set guidelines on how and when the coupons will be used. Remember, young children can't wait very long.

The coupon idea can also be extended to adults. For adults a coupon might be good for help in moving, sewing, repairing something, with child care; a collection of small items that you've observed the person needs; a poem about the person or a list of things you enjoy about that person; or preparing and delivering a special dinner.

## Siuslaw Center under the microscope

The college, through an outside research firm, recently conducted a telephone survey of 400 residents in the Florence area to determine attitudes, opinions, and perceptions concerning the Siuslaw Center.

Among the findings:

- \* 42% percent reported they or an immediate family member had taken a class at the center within the past three years.
- \* Most (67%) took classes for personal interest rather than improving job performance (19%) or preparing for a new job (16%).
- \* 40% of the sample plan to take a class or use a service at the center within the next three years.
- \* Respondents felt the center was doing a good job in appearance and maintenance, variety of classes offered, and convenience of class schedules.

*Trends and their implications for Lane*

People in technical jobs now make up over twenty-five percent of the Oregon workforce, and the percentage is expected to increase. Oregon now imports technical labor because too few

students prepare for science and technology careers. In addition, there is an urgent need to retrain workers. Oregon will be more effective in attracting, keeping, and expanding high tech businesses if a trained workforce is available.

What does this mean for Lane? Links between Lane and public schools are critical for urging students to enter technical and scientific areas. ## Decision-making policy developed

A proposed Board of Education policy on shared decision-making may be placed before the Board for a first reading at its Dec. 13 meeting, with possible adoption considered at the Board's Jan. 10 session. The proposed policy, developed by College Council and approved by Interim President Jack Carter, reads: "The president shall assure broad employee and student representation and participation in college decision-making. The college community has the right to address the full range of educational and administrative concerns. Free expression of opinions is encouraged to facilitate and improve both the process and product. Decisions are to be made as closely as possible to the point of action and to involve those who are significantly affected. Successful implementation of this policy may be judged on the basis of perceived employee and student trust, commitment, communication, and openness."

In other business at its Tuesday meeting, the Council discussed possible college participation in the statewide Ed-Net television system. A committee, chaired by Jim Ellison and including Cynde Leathers, Pat John, and Dick Reid, put together a list of estimated costs of \$11,000 for Lane to become a receiving site and about \$96,000 to become a sending site. The college is keeping its options open, it was indicated, without committing at this point to participation.

At its session next Tuesday, Dec. 12, the Council is scheduled to discuss its agenda for the rest of the college year.

## Tuition hike studied

A proposal to increase tuition by four to five percent for the 1990-91 school year may be recommended to the Board at its Dec. 13 meeting. The Board may only discuss the issue this month and consider action at the Jan. 10 meeting.

Two proposals have been discussed: one to change the maximum credits assessed from 11 to 12 to raise \$294,000 in additional income, and a second to increase the rate per credit from \$24 to \$25 to raise an additional \$223,000.

The Tuition Committee is chaired by Vice President Bob Marshall. Members include managers Tom Reimer, David Marotta, Jim Keizur, Verne Whittaker, and Linda Waddell, and student Scott Derickson.

## Levy may be on March ballot

Interim President Jack Carter will recommend to the Board that it place a three-year \$2.1 million serial levy on the March 1990 ballot. The money would be used for purchasing equipment (primarily instructional) and for maintaining

buildings. No new taxes would be sought; the levy would continue support that has been extended for equipment and maintenance since the college was established. The public would simply continue to protect its investment, Carter said. The Board may discuss the issue at its Dec. 13 meeting and will need to make a decision no later than its Jan. 10 session if it wants to get on the ballot.

The present levy for equipment and maintenance runs through June 30, 1991. The new money would be levied in 1991-92, 1992-93, and 1993-94.

Lane has to be on the March 1990 ballot with or without the proposed levy, because three Board members (Martin Lewis, Peter Sorenson Cindy Weeldreyer) are up for election or re-election. Adding the levy issue will not increase the college's election costs.

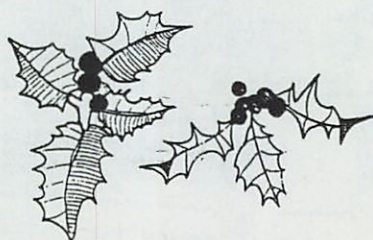

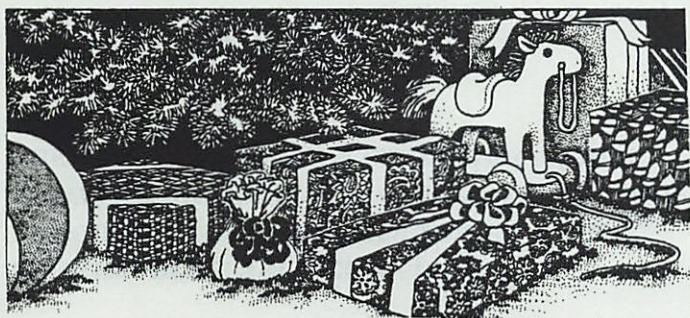

## Watching the horizon

### *Trends and their implications for Lane*

A growing number of Californians are moving to Oregon. Real estate transactions, moving company statistics, driver's license records, newspaper articles all attest to this phenomenon. Factors underlying this in-migration are housing costs, overcrowding, saturated development, earthquake concerns, and disillusionment.

What does this mean for Lane? Population projections for Oregon, in general, and Lane County, in particular, show lower increases in the '90's than nationwide, and predict reductions in traditional college-age groups. The influx of Californians, and others, is likely to result in significantly greater population increases than expected, and a lowered reduction of 18 - 25 year olds with a positive impact on Lane enrollments, credit and noncredit. -- Larry Brown, IRP&E.


